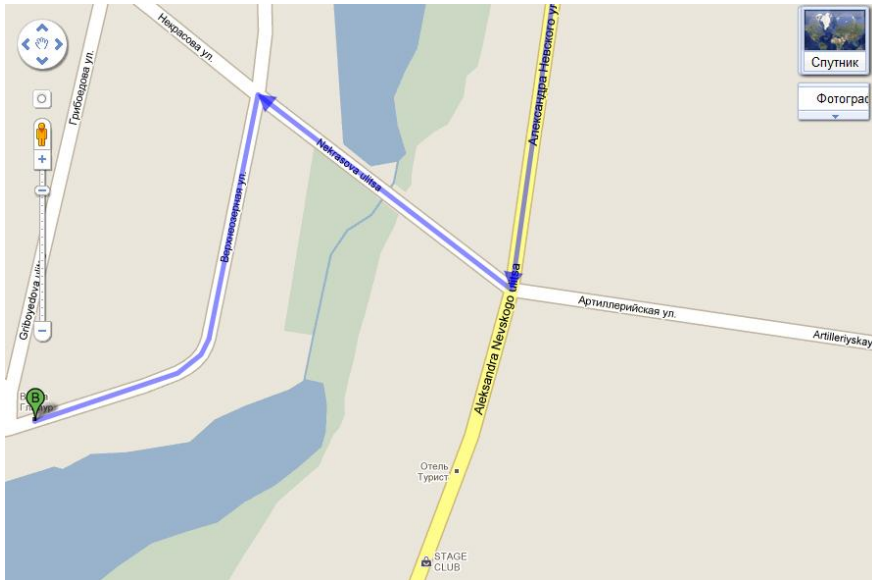

The bus departs from the Airport at 08.00, 09.00, 11.00, 12.00, 12.50, 13.50, 14.30, 15.00, 16.00, 17.10 and 18.10. Please ask the driver to stop at the crossroad of A. Nevskogo str. and Nekrasova str. From there, it is a 5 minutes walk to Hotel Villa Glamour (please see the map below for directions).

For those who wish to take a **taxi** from the Airport, approximate price to the Hotel Villa Glamour is about 500 RUB.

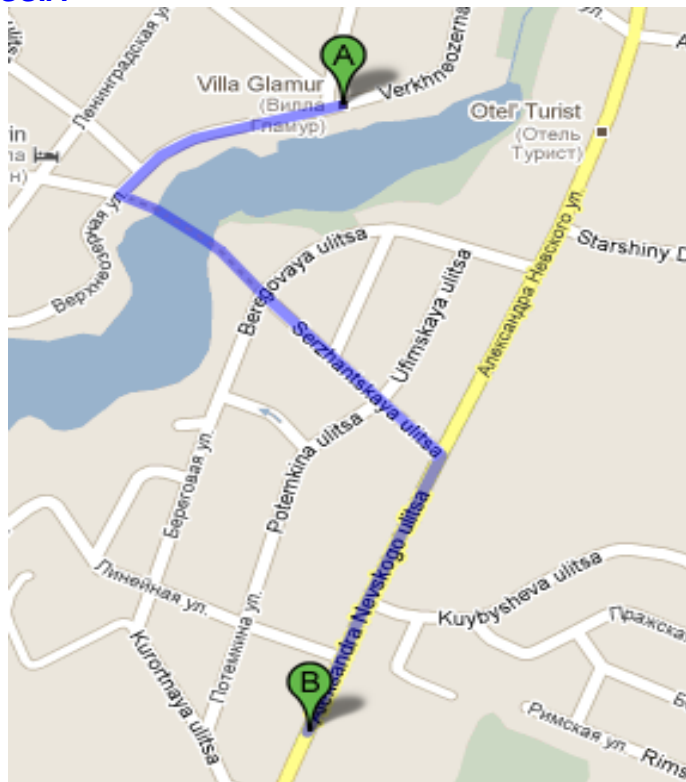
Travel from Hotel Villa Glamour to the meeting venue at Immanuel Kant State University of Russia
