Dear Sir/Madam,

The NDPHS /SIHLWA is the most recently (2005) established expert group and is still seeking its most effective ways of functioning. It has 3 sub-groups:

- 1) Subgroup on alcohol
- 2) Subgroup on adolescent health and socially-rewarding lifestyles
- 3) Subgroup on workplace health and safety

It would be important that Member States and Organizations would carefully consider the nomination of representation to each sub-group separately, as technically it will not be possible for one person to be operational in different subgroups at the same time.

Below you will find an updated table of SIHLWA nominated representatives as we understand it at the moment. Invitations to the next SIHLWA meeting 30/11-1/12 have been sent directly to the members nominated by Member States, if the nomination has previously taken place. Additionally we are sending the meeting documents and information to the named country representatives of NDPHS/ Committee of Senior Representatives to facilitate the process. We would appreciate from the country authorities, if possible, to have an explicit confirmation on the SIHLWA representation and affirmation that we have understood your previous SIHLWA nominations in the right way. Should there be any question marks under respective subgroups, it would be helpful if you could inform us about your intention to nominate a representative from your country/organization.

As an agreed principle of the CSR the representatives attending expert group meetings should primarily be funded by their respective countries and/or organizations. Therefore, it is likely that national representatives need to approach you for financial support to enable their participation in the meeting.
